Bernhard Egert and Roman Ehrentraut join forces to succeed Werner Huber as technical managing directors in Germany

Vienna, 7 March 2024 – As Dr Bertold Wild is due to leave the company to enjoy his retirement from mid-May, industry insider David S. A graduate architect and urban planner, he has over 30 years of experience in the industry and is well connected.

“With his expertise and experience, David Christmann will not only lead UBM in Germany through the current industry crisis, he will also further develop UBM’s high-profile projects and our competence in timber construction,” says Thomas G. Winkler, CEO of UBM Development AG, the Vienna-listed parent company of UBM Development Deutschland GmbH.

“I am looking forward to the new responsibilities and new colleagues. The aim of becoming Europe’s biggest timber construction developer was decisive in my motivation to forge ahead with full strength,” adds David S. Christmann.

“At the age of almost 70, and as the permits have been settled for our Munich projects, it is now finally time for a new chapter in my life. Although part of me will always remain with UBM,” says Bertold Wild, looking towards his retirement.
